ASSESSMENT

COURSE DELIVERY:

Face to Face (F2F):

Participants will be guided through the course content and assessments over a four-day intensive program and will benefit from sharing experiences, knowledge, and challenges with industry peers. The intensity and depth of contact during the intensive provides an opportunity to build lifelong networks for mentoring and support.

Live Stream Sessions (Four full day course or some courses offered over eight half days):

Participants will be guided through the course content and assessments throughout the sessions, and will benefit from sharing experiences, knowledge, and challenges with industry peers. The relationship built through the depth of contact with your peers during the sessions, provides an opportunity to build lifelong networks for mentoring and support.

Distance Learning:

Designed for those who may wish to study part time, the distance learning model allows for some flexibility. From course pre-reading to final assignment submission, the distance learning option would take approximately six to twelve months. Successful students will be awarded the 10980NAT Graduate Certificate in Compliance and Risk Management, a nationally accredited qualification with skills to excel in leadership positions. Those students who are also financial members of the Australian Compliance Institute will be eligible to apply to be accredited as a Certified Compliance and Risk Professional and may display the post nominal CCRP.

COURSE EXEMPTION

Experienced professionals may be eligible to demonstrate their competence and expertise through recognition of prior learning (RPL). Initially, applicants will be asked to send a detailed CV, and any relevant transcripts, to ascertain suitability. If accepted, the applicant will then be advised of the cost of the RPL process. On payment of the fees, they will receive the RPL kit to record their portfolio of evidence demonstrating their skills and expertise corresponding to each of the course competencies. Applicants may also demonstrate their eligibility for credit transfer (CT) by providing statements of attainment awarded by other Registered Training Organisations.

REGISTRATION

ENTRY REQUIREMENTS

Students must have at least five years' experience in a compliance or risk related role with two of those years in a senior/management position. Students must submit a CV to demonstrate the work experience required. In preparing for the course, students must complete a pre-module assessment which will be provided shortly prior to the course date.
