## Course Description

This qualification reflects the role of individuals who apply knowledge and skills in a compliance and management role which may include aspects of anti-money laundering and counter terrorism financing. Individuals at this level make autonomous decisions and use initiative and judgement to assess and design a range of anti-money laundering and counter terrorism financing functions in varied contexts. They have full responsibility and accountability for personal outputs and for the work or function of others.

They use cognitive and creative skills to review, critically analyse, consolidate and synthesise knowledge, in order to generate ideas and provide solutions to complex problems. They use communication skills to demonstrate their understanding of theoretical concepts and to transfer knowledge and ideas to others.

## Target Cohort

**This course is intended for:**

- Existing workers (3+ years' experience) at a banking or financial institution
- Professionals working in, or aspiring to work in, compliance, risk management, or financial-crime roles within financial services and related industries
- Existing workers seeking to develop advanced capability in AML/CTF, including those currently employed or moving into compliance, risk, or financial-crime prevention roles across banking, superannuation, insurance and government
- Professionals who hold, or are preparing for, responsibilities in managing or overseeing AML/CTF functions within financial services and other regulated sectors
- learners with relevant industry experience or prior formal study who are looking to strengthen their expertise in AML/CTF frameworks, regulatory obligations and financial-crime risk management
- Existing workers seeking RPL/Credit transfer.

## Entry Requirements

**Entry to this qualification is limited to those individuals who:**

have completed a Diploma or Advanced Diploma qualification in related fields of study

OR

have completed a Bachelor degree in related fields of study

OR

have three years equivalent full-time relevant workplace experience at a banking or financial institution with exposure to transaction processes, controls, and/or client onboarding.

## Entry Requirements (Continued)

The ACI requires learners to:

- Be over the age of 18 years
- Have English language, literacy and numeracy skills at or above ACSF Level 3 and complete LLND assessment
- Relevant prior training and/or employment
- Have access to a workplace or simulated environment to complete assessment tasks
